# Considering Taking a Gap Year?

How to Make an Informed Decision



"A gap year" is the term for when you take one year off between high school graduation and post-high school (or postsecondary) enrollment. Students who take a gap year typically may use this time to volunteer, work, or travel.

You may be exploring the possibility of taking a gap year or postponing your college or career education after high school. For current high school seniors, here is what you need to know about postsecondary (after high school) options to help you make an informed decision and plan.

#### Challenges of a Gap Year:

- Students who choose to delay are at considerable risk of not completing a postsecondary credential compared to their peers.
- It can be costly, and you may lose momentum or get sidetracked.
- You may no longer have access to a school counselor to help you navigate the admissions and financial aid process.
- If you were awarded a seat in a competitive major or program, you may lose that placement.
- You may need more content knowledge in a subject you can test out of (e.g., foreign language, math, and English).
- Due to COVID, employment and travel may be unreliable options.

#### Benefits of a Gap Year:

- If you are employed, you can gain work experience, possibly in the career field you want to pursue.
- If you can volunteer, you can gain experience in community service and explore career fields and interests. It can also strengthen a college application.
- Employment and volunteering can help you strengthen soft skills like teamwork, problem-solving, communication, and time management.
- This time is an opportunity to explore options and interests before committing to a college major or training program.



## Gap Year & Other Options

**DEFERRED ENROLLMENT:** "Deferred enrollment" is the ability, process, and procedure to postpone starting classes for a semester or year at your selected college. This process will vary by school or program. Traditionally, some schools will review and approve the request on a case-by-case basis, while some approvals are automatic. Contact the admissions office to find out their options and how to proceed.

AMERICORPS: AmeriCorps is a national service program. Members volunteer to address critical community needs like increasing academic achievement, mentoring youth, fighting poverty, sustaining national parks, preparing for disasters, and more. Most members receive student loan deferment (if needed), training, a living allowance, and limited health benefit options. After a completed term of service, they receive a Segal AmeriCorps Education Award (equivalent to the value of a Pell Grant) to help pay for college, graduate school, or vocational training or to repay student loans. **EMPLOYMENT/INTERNSHIPS**: You can explore employment or internships during a gap year. Factors you should consider include housing, transportation, and living costs. It is challenging to find paid internships if you are just out of high school. When searching for a job:

- Be aware of your public social media presence. Potential employers may check your social media accounts before hiring.
- Use a professional-looking email address on job applications, and check that account regularly. Also, remember that
  postsecondary schools and programs periodically communicate through email accounts and will expect you to check them and
  respond regularly.
- Research and practice building cover letters, job applications, resumes, job interviews, and follow-up etiquette.

**ONLINE AND COMMUNITY COLLEGE OPTIONS AKA THE VISITING YEAR:** If you have been admitted into a residential four-year school and need to change plans, you might consider a "visiting year" option. A visiting year is an option that allows you to complete introductory courses and stay at home. During the year, you would:

- Enroll in a local community college, online college, or program for one year.
- Aim to take 30 credits of general education classes. You may be able to transfer these credits and return to your 4-year school.
- This option offers you a chance to reduce the cost of college and stay on track for on-time graduation. You should contact your
  college to find out if they provide deferred admission. If so, can you take classes at another institution during a deferment
  and maintain your enrollment status? You must understand and follow their rules about deferment, transfer, and the number of
  credits you can earn during this period.

### Decide on Pathway for The Fall

- If you have accepted an offer of admission from a four-year college or university and have concerns about attending in the fall, contact the Office of Admissions as soon as possible to learn about your options. You must talk to them about the process for taking a gap year. When deciding what option works best, you should consider these essential factors:
- Does your school require you to submit an Intent to Register, a deposit, and/or a statement about your plans? Do you need to complete a deferral agreement? You should wait to be notified to see if you have been granted a deferral of admission and scholarship (if applicable).
- Will you lose your place if you had been awarded a seat in a highly competitive program or significant? If you had been selected, would you lose your place in a support program like TRiO, CAMP, or First-Year Experience?
- Will your school require you to submit a new application and fee? Will you need to retake admissions or placement exams?
- You should check with your scholarship providers to see if and how your scholarships may be deferred. If you have applied for financial aid, you must submit a new FAFSA or WASFA as soon as possible after October 1 for the next school year.
- Can you contact your high school counselor for support and guidance now? Can you do this fall when reapplying for financial aid?
